

**CONGRESS OF THE FEDERATION INTERNATIONAL OF POWERCHAIR FOOTBALL 2022
MINUTES**

November 5, 2022 via Microsoft Teams
12:00 PM UK Time

The Congress was called to order at 12:01pm UK time by President Ricky Stevenson. Directions for the meeting were given and members were encouraged to speak and allow time for translations.

The roll call was completed by Barb Peacock, Secretary General.

- The official attendance sheet has been added to the end of these minutes.

The agenda for the meeting was reviewed.

The introduction included a welcome by Ricky to the 14th Congress, the 3rd held completely virtually. He hoped everyone is well and that they've had a chance to get back on the court. 2022 has seen the return of international play.

Zone updates:

- Americas Zone report given by Alberto Martinez (MEX):
 - Member nations have returned to play:
 - Argentina national team has been training and local leagues have returned to competitions
 - Brazil held a summit in July for all aspects of powerchair football
 - Canada held a tournament in Montreal, which included some teams from the USA
 - Mexico began its first national league with 4 teams, some travel to the USA for competitions.
 - Uruguay club training and local competitions have resumed
 - USPSA participated in a disability month held by US Soccer last December. National tournaments were held in June. USA national team is now supported by the US Soccer Federation.
 - Copa Libertadores (6 club teams) and Copa Sudamerica (3 national teams) will be held in mid-November in Argentina
 - Working with Guatemala, Chile, and Colombia to start the sport
 - Mariano offered to help with expansion in Chile. Alberto to send contact information
- Asia/Pacific/Oceania Zone report given by Tristram Peters (AUS):
 - Four full members have returned with national and local team trainings and competitions
 - India, Singapore, and Nepal are developing the sport
 - Current nations are working toward 2024 national cups and the 2023 FIPFA Powerchair Football World Cup (FPFWC)
- European Zone report given by Donal Byrne (IRE):
 - September 2021 saw the resumption of many of the domestic leagues in our NOPFS, our online supports, planning for clinics and our other off court activities.
 - online sports psychology sessions
 - referee trainings course in Scotland and Spain
 - classification clinics in Spain and Italy
 - coaching sessions in Germany
 - EPFA also continued involvement with Integrated Dreams and the Football For All Leadership Programme. EPFA co-sponsored Michael Kiefler (AUT) and Carlos Filipe (POR)

- Held 2 Home Nations Cups in Northern Ireland in April and May featuring the senior and developing squads from Ireland, Scotland, England, and Northern Ireland.
- EPFA representatives attended the UEFA's Fan Festival at the Europa League Final
 - EPFA will continue with its partnership with UEFA
- Held the inaugural EPFA Cup, tournament for new and developing nations. This competition qualified Belgium, Scotland, and Germany for the 2025 EPFA Nations Cup
- Planning future events for the next 3 years and are looking for hosts for the EPFA Clubs Cup, EPFA Champions Cup, and EPFA Nations Cup

Secretariat Report given by Barb Peacock (USA), Secretary General:

- Typical duties include:
 - Manage the day to day business of FIPFA
 - Communication with partners, Zones, and NOPFs
 - Prepare annual reports
 - Organise the annual Congress and share the minutes with attendees.
 - Others as assigned by the president
 - Executive Council (ExCO) meetings
 - Work with the President to prepare each agenda
 - Create and disseminate minutes of all meetings
- Also this past year Barb has:
 - Worked with Sophie Bevan on the LA28 bid submitted to the IPC
 - Represented FIPFA at EPFA Home Nations Cup in Belfast and the EPFA Cup 2022 in Geneva
- Goals for the Secretariat:
 - Find more sponsors
 - Increase membership
 - Improve visibility of FIPFA
 - Continue to improve communication with Zones, NOPFs, and other countries who play the sport.
- Barb also added that communication is important and for nations to update their websites, send in new photos

Review of the election process reported by Barb Peacock:

- To be run by Alex Dowding, was discussed.
- Two separate elections to be held toward the end of the Congress

 - President

- Ties to be broken by Ricky (Constitution only) and John Moore (IRE), FIPFA Treasurer, (president only)
 - Pernille Sorensen (DEN) questioned if the Zone representatives could break the tie instead as she felt that that John is too involved with the board.
 - Ricky responded that he understood the point, but the Zone Presidents are involved with the Board and were part of this discussion and decision, which aligns with the Constitution.

- Questions:
 - Niels-Christian Simonsen asked about the ASC between their sponsorship and cost.
 - Ricky responded that they are a partner, but that we have to pay for the licence to use their product that we are creating for powerchair football

Reflections by Ricky Stevenson (ENG), President:

- Post last year's Congress we moved operations from France to England and opened a new bank account.
- 2021 started with difficult decision to postpone the FIPFA Powerchair World Cup until 2023
 - Meetings were held with all qualified nations all 10 nations agreed the new timeline

- Met with our Elite partner Power Soccer Shop to discuss and agree to extend the partnership one year
- Attended a meeting with IPC to learn more about the bid process and timeline for the LA 2028 Paralympic Games, which led to lots of work by members of the ExCo to gather the evidence of where and how our sport is played across the globe for the application
 - In April the new website was launched with lots of work by Ryan behind the scenes to showcase our sport across the globe.
- First international event happened in April in Northern Ireland getting us back on court internationally.
- The bid process for the 2026 FIPFA Powerchair Football World Cup began
 - 2026 was decided upon in the workshops held in 2021
 - Multiple bids have been received and we will announce the host next year.
- Have worked on the proposed new constitution which will give the federation a strong foundation to build on as we move into 2023.
- We are aware of more nations starting to play the sport and this is a focus for us to develop more nations and start to grow again. This is a priority.
- Ricky thanked the board and officers of FIPFA for their commitment over the last year
 - They continued to meet monthly and keep abreast of the developments of the sport and organisation.

Partner Updates report given by Ricky Stevenson (ENG), President:

- Reviewed and extended the Power Soccer Shop partnership through to the 2023 PPFWC
 - We wanted to ensure they had the opportunity to be a part of PPFWC and this also gives time to work with them.
- It's been difficult for them with the pandemic plus lack of materials, electronics needed to build the chairs.
- Partnership funding has been less due to less activity by FIPFA
- Yoola:
 - We have continued our partnership with Yoola as a travel partner and they have supported travel with the events and activities we have attended this year.
- International Paralympic Committee (IPC):
 - We continue to be a recognised Federation by IPC, which allowed us to apply to participate in the LA2028 Games.
 - In mid-November, Sophie and Barb will attend IPC General Assembly to ensure IPC sees our commitment and to continue to develop the relationship with them.
- Para Football:
 - Last year we reported that we had been part of this formation of Para Football impairment groups and either Donal or Ricky have attended the quarterly meetings.
- Goals Beyond Grass (GBG):
 - Moved our website and database
 - Supporting us with the Election Runner System for this Congress
- Academy Sports Coach (ASCCloud):
 - 2nd year of partnership with them, a number of coaches from across the membership have had free access to the programme.
- FIFA:
 - Worked with them to produce a resource for member nations on all para football, this was completed but due to changes in FIFA it is under review
 - Ricky met the person leading this work at FIFA in July at the Football For All Leadership Awards event and discussed how we can collaborate more.
- Questions:
 - Craig Peattie (SCT) asked about the timeline for the LA 2028 bid

- Ricky responded that there is an initial response early 2023 and that there are 23 slots for 33 sports that are applying
- Sophie added that first notification should be to us by end of January 2023 and final decision will be mid to late 2023.
- Nuri Onanmis (GER) asked about our plans for developing countries, also if we had a special program for them
 - Ricky answered that FIPFA has agreed to work by Zone for development of new countries, but that we need to work collectively. Do not have a set program yet, but need to look at how we can best support each other
- Mariano Zegarelli (ARG) asked about how the new countries in Europe are growing, how many players, tournaments, etc.
 - Ricky answered that in order to become a full member, they need to have a national tournament. Italy became full this year as they started national competitions in 2021 and Mexico will become a full member next year as they started national competitions this year
- Alberto followed up with Mariano's question stating that the biggest issue with development is financing.
 - Ricky responded that financing is always the issue, but that, if the new constitution passes, the charity status will help bring in funds. Also, that we need to have regular dialogs with the nations in the Zones to share info on how to develop new nations. Ricky shared EPFA's success in working with UEFA and their partners for development. He added that Donal Byrne has offered to share information with other Zones.
 - Ricky also mentioned the Development Conference held through UEFA at the 2011 World Cup in Paris. Nine countries attended to learn more about powerchair football.
 - Mariano asked to have other Zoom meetings for sharing
 - Ricky said this is easiest to do by Zone because of time zones and availability of nations to meet. To be looked into for next year.

- Details from nations have been sent to the LOC with numbers in the delegations and the estimated dates of travel
- Of the 9 coming, 3 have paid up in full, 5 will have it all in by end of November. Only one needs to communicate with the LOC.
- Invoicing will be sent by mid-December for extra accommodations, etc., and will be due end of February.

- Changes to delegation size and/or arrival and departure dates will need to be in by end January
- Firm commitments of non-refundables will start in February
- Medical equipment needs, specific names and numbers due by end June/July
- Scrimmage requests with New Zealand have been received and schedule is being organised
- LOC is finding extra courts for training and will have info by the end of this year
- Ricky added that the qualified nations have been meeting with the LOC quarterly
- Questions?
 - Niels-Christian Simonsen asked if there will be information coming out the specifications of the wheelchair prior to the event
 - Ricky responded that we are working with a university on all aspects of the equipment and if there are to be any changed, they will be announced by May. ([See current Technical document on the Website](#))
 - Steve Everett (USA) asked if the structure will be round robin. Answer was Yes.

Sports Department Update given by Sophie Bevan (ENG) and/or Department Leads:

- Technical Update – Officer position has been vacant, despite recruiting
 - A technical committee who work together on the many different technical aspects of our sport which will be led by a technical officer.
 - In early 2023, FIPFA will advertise for committee members. Full role profile and further details to be provided.
- Competitions Update given by Sophie:
 - Hanna Kwitko, (BRA) Competitions Officer
 - Due to Covid-19 and other commitments, she has not yet attended events, but FIPFA has supported 3 sanctioned events this year
 - All Zones were encouraged to send calendar of events for 2023 onwards in order to plan for necessary support if events are to be sanctioned
 - FIPFA will be review the sanctioning application process in 2023
 - Minimum of 6 months' notice necessary for paperwork to be received by Director of Sport
- Referees Update prepared by Martin Bevan, (ENG), given by Sophie
 - Continues to work with referees in the Zones, with the main focus on the team for the 2023 World Cup, ensuring the best referees are available
 - Martin will use an event in Australia early next year to certify some international referees to support the World Cup
 - Goals for Future:
 - Prepare a log to give a clear evaluation of each potential World Cup referee. The Zone Heads will update to ensure the strongest officials are at the World Cup
 - Develop a handbook with recommendations for referees.
 - Referees for all Zones and NOPFs to assist in the development of this
 - Hold a 2 to 3 day workshop on Laws of the Game inviting 2 referees from each World Cup qualified nations
 - Ensure consistency of the interpretation of the Laws
 - To be held in person ahead of the World Cup with classroom and court training
 - Questions?:
 - Steve Everett (USA) asked if there will be specific settings required for the chairs in order to have a level playing field
 - Safety and technical aspects will be looked at by referees.
 - Nathalie Delplace (CHE) asked if it were possible to have Competitions Officers in each Zone instead of just relying on just one.
 - Possible to look at this in the future, others from the Zones have filled in this year

- Nathalie also stated that it would be better if Martin and Stewart were at this meeting to present and to answer questions
 - Ricky replied that Congress is to update the status of FIPFA and to ask any questions when needed. It is possible to have other meetings to hit on specific topics
- Nathalie asked who would pay for the referees training
 - Sophie replied that the specifics were to be determined, but most likely will be at the World Cup
- Niels-Christian Simonsen (DEN) asked where to find the technical information on the wheelchairs and had a concern that only the StrikeForce chair is allowed
 - Sophie responded that the Technical Supplement can be found on the website under Laws of the Game, and that the picture in the document shows a StrikeForce chair in order to dimensions, but that any wheelchair that meets the described specifications will be allowed. Sophie will check to make sure the document is available on the website
- Craig Peattie (SCT) proposed quarterly meetings
 - Ricky replied that Zone meetings would be best due to time zones.
 - Craig asked how then to share good practices across Zones
 - Ricky responded that Zone Presidents are involved in monthly ExCo meetings and do share
 - FIPFA will take action to look to how to best do more topical meetings with members
- Classification Update prepared by Stewart Evans, (ENG), given by Sophie:
 - The extreme hiatus caused through Covid has meant that classifiers have not had opportunity to use their skills for several years.
 - Recruitment of classifiers has been a challenge for recent Zone events. Current classifiers will be polled as to their level of commitment.
 - Will look to promote national classifiers from NOPF's who have invested in classification and utilise it in their national leagues.
 - Will run classification courses to train prospective candidates for national leagues across all Zones. Please contact Stewart if interested
 - The Postgraduate research project being undertaken in Virginia USA by Dr JP Barfield and his team is nearing completion.
 - The proposed changes are in line with current assessment practice and unite with requirements of the IPC for a quantitative research approach.
 - Report and recommendations to merge with the current classification system in the late summer of 2023
 - Introduce as a demonstration model at the World Cup, but for full implementation during the next 4 years.
 - National level database that is fully integrated into the International version is available to NOPFs for a fee of £400 (€466) per NOPF
 - The new required quantitative assessments will be integrated
 - Stewart is planning on stepping down in the future, but FIPFA classification programme will continue and will strive to follow IPC guidelines in order to support our application for full participation at Paralympic events
 - Questions:
 - Pernille Sorensen (DEN) asked why FIPFA cannot give the database to each NOPF
 - Sophie said that this was discussed at last year's Congress as a possibility, but that it would have increased the membership fees for all, when some NOPFs may not want to use it

- Ricky also added that this access gives the NOPF their own national database and it would be far more expensive to create their own
- Anti-Doping Update given by Graham Arthur, (ENG)
 - An effective operational anti-doping program is an important part of the sport's growth and development strategy. It adds to the credibility, integrity, and status of the sport
 - Also necessary to support public authority engagement and major event participation.
 - Anti-doping operations first require players and player support personnel to be aware of key matters concerning anti-doping. This is a fundamental requirement of the World Anti-Doping Code.
 - Essential features include –
 - Doping Control process
 - Information, practice and guidance regarding the process for obtaining exemptions for the use of medications through Therapeutic Use Exemption (TUE).
 - Awareness of supplement and nutrition product risks
 - These are not subject to the same labelling and production standards as medications and may contain banned substances the user is not aware of
 - Lack of awareness is not excused
 - FIPFA progress
 - In person education sessions to teams and staff
 - May 2022 – Ireland, Northern Ireland, England & Scotland
 - August 2022 – Austria, Belgium, Germany, Italy, Spain, Switzerland
 - Graham suggested that time for Anti-doping education be considered as part of sanctioning an event. Also during training sessions as it is best done in person with groups of athletes and support staff
 - Development should continue with:
 - Further team, staff, and support awareness
 - Localised online training resources
 - Risk analysis/consultation with WADA
 - TUE Process to be in place soon
 - Testing Plan to be developed
 - Strategy of this plan is unfortunately 2 years behind
 - Questions:
 - Nathalie Delplace (CHE) related that in the debrief of the EPFA Cup, the countries asked for more detailed information regarding exemptions, forms, and process
 - Graham said that a nation by nation analysis needs to happen. Some nations will be able to get TUEs from their national anti-doping agencies (NADA). WADA recognises NADA TUEs. But FIPFA needs to be a signatory to the WADA first.
 - Collaboration with NADAs is best path.
 - The process is the player applies to the NADA with what medication they wish to use and why. The TUE body assesses and verifies the medication is necessary, will not provide a benefit for the athlete, and has no reasonable substitute that is not on the banned list.
- Coaching Update given by Sophie

- Jeff Davis, (ENG), appointed by FIPFA in December
- Started our partnership with Academy Sports Coach and their exclusive AscCloud® software to support the development of coaching opportunities.
 - Provides dedicated resource to support development and growth of educational and coaching programmes for Para athletes and coaches.
 - Trial licenses given to interested coaches who attended 2020 workshops
 - Contact Jeff at coaching@fipfa.org or Sophie at sport@fipfa.org for trial licenses, full licenses, and/or more information
- Future plans:
 - Looking to create a coaching network and community which collaborates and shares good practices for the good of the game.
 - Set up forums for coaches around the world to help guide, support, and educate those involved in powerchair football.
 - Set up virtual masterclasses with the coaches in the game
 - Develop a Coaches Working Group to help formulate a Level One course and produce resources to support all those who choose to work within this area of the game.
- Questions:
 - Craig Peattie (SCT) asked if Jeff has coached powerchair football
 - Sophie answered that he is not here as a coach of powerchair football, but is assigned as a skilled coach of football and to share his expertise to our coaches
 - Craig asked about time frame - appointed in December and started in May
 - Ricky answered that it took FIPFA time to get things in place
 - Craig asked if others had applied
 - Ricky answered that no one had indicated an interest in leading the coaching area when asked in the 2020 workshops, so FIPFA made a direct appointment
 - Mariano Zegarelli (ARG) stated that our focus should be more on the players and development of the sport, and to have for more activities and tournaments
 - Penile Sorensen (DEN) questioned about so many people who are appointed are from England. Why did we not physically call and ask more of the national coaches to apply?
 - Ricky stated that in the workshops we did ask for support and coaches indicated they wanted to help, but not head the group. Jeff is a specialist in coaching who can bring resources together.
 - Sophie added that we want a working group, but people need to step-up.
 - Craig asked if there will be communications going out to the NOPFs for coaches to join this group
 - Sophie said Jeff will be sending out requests for coaches to help soon

Constitution Update:

- 2021 Congress discussed a new Constitution to create charity status
- In September, the document was resent to the NOPFs
- Questions;
 - Pernille Sorensen (DEN) asked several questions for clarification of this document
 - Ricky answered:
 - The nations who pay fees are the members

- Trustees are the elected Board members
- The new Constitution gives liability protection to the Trustees/Baord
- Also gives better foundation to get more people on board
- More opportunity to secure more partners
- Most similar organisations are set up this way
- Elections remain the same
- Handbook is needed for the protocols and processes to function
- Vote was called, link was sent to the 18 available voting members, check was done to make sure everyone received it, and Alex Dowding (Moderator) resent link to two.
 - 94% participation (see NOTE below)
 - Yes – 16 votes (94%)
 - No – 0 votes (0%)
 - Abstain – 1 vote (6%)
 - Motion passed.
 - Ricky thanked Graham Arthur for his help and support to get all of this information about the Constitution in place.

Election for President:

- Ballots were sent at this time
- Comments from the two candidates were given
- Vote was called and completed
 - 94% participation (see NOTE below)
 - Ricky Stevenson (ENG) received 11 votes (65%)
 - Sebastian Tisera (ARG) received 5 votes (29%)
 - Abstain received 1 vote (6%)
 - Ricky is elected as President for the next 4 years


NOTE: Brasil was present in the meeting, but did not respond when asked to vote.

He thanked everyone for joining and reminded everyone to please contact any of the ExCo if they have questions.
